

Privacy Policy

We respects and protects the personal privacy rights of all users of network services. In order to provide you with more accurate and personalized services, we will use and disclose your personal information in accordance with the provisions of this privacy policy. But we will treat this information with a high degree of diligence and discretion. Unless otherwise stated in this privacy policy, we do not disclose or provide this information to third parties without your prior permission. We will update this privacy policy from time to time. By agreeing to our Internet service agreement, you are agreeing to the full content of this privacy policy. This privacy policy is an integral part of the network services usage agreement.

1. Scope of application

- A) When you register your account, you provide personal registration information according to our request (except the business name and related business registration information that the business should be published in accordance with laws and regulations) ;
- B) When you use our web services or visit our platform web pages, we automatically receive and record times on your browser and computer, including but not limited to your IP address, browser type, language used, date and time of access, software and hardware features, and web records of your requirements;
- C) The user's personal data that we have legally obtained from our business partners.

You understand and agree that the following information is not subject to this privacy policy:

- A) The keyword information you enter when using the search services provided by our platform;
- B) The relevant information and data collected from your website, including but not limited to participation activities, closing information and evaluation details;
- C) Even acts against the law or our rules and the measures we have taken against you.

2. Information usage

- A) We will not provide, sell, rent, share or trade your personal information to any third party who is not related to you, unless we have obtained your prior permission, or the third party provide services to you individually or jointly, and after the end of the service, they will be prohibited from accessing all such information including the information that they were previously able to access.
- B) We also do not allow any third party to collect, edit, sell or distribute your personal information without compensation. We have the right to terminate the service agreement with any user of our platform who engages in the above activities.
- C) For the purpose of serving users, we may provide you with information of interest to you by using your personal information, including but not limited to sending you information about products and services, or sharing information with our partners so that they can send you information about their products and services (which requires your prior consent) .

3. Disclosure

We will disclose all or part of your personal information if you so wish or if required by law:

- A) Disclosure to a third party with your prior consent;
- B) In order to provide the products and services you require, you must share your personal information with all three parties;
- C) Disclosure to a third party or an administrative or judicial body in accordance with the relevant provisions of the law or at the request of an administrative or judicial body;
- D) If you are in violation of Chinese laws, regulations or our service agreement or related rules, you should disclose to a third party;
- E) If you are a qualified intellectual property complainant and have lodged a complaint, you should disclose it to the complainee at the request of the complainee so that both parties can settle possible rights disputes;
- F) In a transaction created on our platform, if either party to the transaction has performed or partially performed its obligations and made a request for information disclosure, we have the right to decide to provide the user with the necessary information, such as the contact information of the party to the transaction, to facilitate the completion of the transaction or the resolution of the dispute;
- G) Other disclosures that we deem appropriate by law, regulation, or website policy.
